

AGREEMENT BETWEEN
THE UNIVERSITY OF MILANO-BICOCCA
AND
L.N. GUMILYOV EURASIAN NATIONAL UNIVERSITY

The University of Milano-Bicocca (official address: Piazza dell'Ateneo Nuovo 1- 20126 Milano, Italy) legally represented by the Rector, Professor Maria Cristina Messa

AND

L.N. Gumilyov Eurasian University (official address: 2 Satpayev street – 010008 Astana, Kazakhstan) legally represented by the Rector, Professor Yerlan Battashevich Sydykov

WHEREAS

the above-mentioned institutions agree to implement a scientific and academic cooperation programme between the two Universities

THE PARTIES AGREE AS FOLLOWS:

Article 1 - University of Milano-Bicocca and University of L.N. Gumilyov Eurasian University intend to promote and to strengthen scientific and academic cooperation by means of exchanging teachers, researchers, PhD students, graduate and undergraduate students and other staff.

Article 2 – Both Universities agree to strengthen their relationship in the different research areas, to undertake joint research activities and joint research doctoral theses. Each party agree to host academic exchanges of teachers, researchers, PhD students, graduate and undergraduate students for the purposes of education, long-term and short-term internship, educational-scientific practices and training, professional practices (educational-manufacturing, manufacturing, research, pregraduation and pedagogical). They also intend to organize conferences and symposia on topics of common interest.

To this end each Party guarantees access to its own research, academic and recreational facilities to the visiting Party.

Article 3 – In the frame of the present Agreement, each Party will designate their own representative who will arrange a yearly joint programme of work and the necessary funding scheme, according to articles 1 and 2, and who will verify the fulfilment of the expected aims.

Article 4 –Scientific and academic cooperation will be implemented through further written Agreements, subject to the approval of the academic boards. The Parties will jointly or individually seek funding from national or international bodies and organizations to finance the scheduled activities. No activity shall be accomplished without the necessary financial support.

Article 5 – The University of Milano-Bicocca will pay insurance costs of its own students and staff participating in the exchange program, limited to accident insurance and third party civil liability insurance. Students from both institutions are required to provide additional health insurance coverage at their own expenses. Different provisions may be given in further Agreements.

Article 6 –Students from both Parties participating in the exchange program are exempt from paying enrolment and fees at the host university. Students should meet all the administrative duties required by their own University. Each party will be responsible for the health and safety of the students during activities carried out on its premises, according to the local and applicable laws and regulations. For the sake of clarity each party confirms and represents that it complies with all the applicable and specific laws and regulations.

Article 7 – Anything regarding intellectual and industrial property, as well as patents and inventions, that may result from common research activities will be regulated by specific written Agreements.


Article 8 – The partner Universities shall make every effort to reach an out-of-court settlement for any disputes that may arise on signing or performing this Agreement.

Article 9 – This Agreement shall enter into force following its signature by all the contracting Parties and shall remain in effect for a period of five years. The Agreement may be renewed or modified by means of a written notice. The Parties may withdraw from the present Agreement by giving a six-month written notice. In the event of termination of the Agreement, the projects in progress shall continue until the end of the current academic year at the least.

Article 10 – The present Agreement will be signed in two originals in English and Russian.
