## **COOPERATION AGREEMENT**

### **ARTICLE 1**

The purpose of this agreement is to establish a close cooperation between the  
.... and the General Linguistics and Translation Theory Department of L.N.Gumilyov  
Eurasian National University.

### **ARTICLE 2**

Both departments will seek to facilitate, on the basis of the available options, in  
the following:

- joint research;
- professional development of teaching staff;
- preparation and translation of manuals and training materials;
- improving the management structure of the universities
- joint seminars, conferences, symposia, etc.;
- exchange of students and professionals of gradual and postgraduate forms of  
training;
- exchange of teachers, researchers and staff on short-term and medium-term  
programs;
- development and implementation of joint bachelor's and master's degree  
programs;
- preparation of joint grant applications and projects in the framework of  
international educational programs;

– finding solutions to other pressing problems related to the implementation of the Cooperation Agreement;  
– the exchange of publications on the full range of cooperation issues  
Exchanges of visits shall be carried out at mutually agreed schedules, and on the number of terms established by the Parties.

### ARTICLE 3

A detailed program of cooperation referred to in Article 2, will be determined every two years by the Administration of the departments or their representatives (responsible for external relations of the departments).

For the activities referred to in Article 2, both departments will seek funding from their own budgets as well as with the support of national and international organizations.

### ARTICLE 4

This Agreement shall enter into force upon signature and shall be valid for five (5) years. Each Party can refuse to continue the cooperation by written notice to the other side about it for the period between 1 – 15 November of the calendar year of the Agreement.

If such notice is not received, the Agreement is automatically renewed for five years.

Termination of the Agreement will not result in the termination of work on the previously agreed and approved programs until their completion.

All changes and additions to the Work program are implemented by the Parties in writing by the authorized representatives of the Parties.


