



## Memorandum of Cooperation



between

**Petra University**

&

**L.N. Gumilyov Eurasian National University**

Sparing efforts to strengthen relations in the fields of education and scientific research and aiming to develop the ties among the academic teams, researchers and students, organizing joint scientific projects and exchange the educational and scientific experiences, **Petra University and L.N.Gumilyov Eurasian National University**, hereinafter referred to as «the Parties», agree as follows:

### Article 1

The Parties cooperate on the basis of friendly relationships established between the Hashemite Kingdom of Jordan and the Republic of Kazakhstan and in accordance with the laws and regulations of the two countries as well as international rules and norms.

### Article 2

The Parties cooperate in training highly-qualified professionals and developing their skills.

The number of undergraduate, postgraduate, doctorate students and professors and their fields of study, study durations and exams shall be determined ad hoc.

### Article 3

On the basis of the Memorandum, The Parties exchange undergraduate, postgraduate, doctorate students and researchers according to the fields preferred by each party, providing that they continue their study. The exchange proceedings shall be determined for every single condition.

In addition to academic exchanges, the Parties cooperate in exchanging students for the various periods and fields of study.

### Article 4

The Parties determine the following directions of cooperation:

- exchange of leading professors and instructors to deliver lectures
- exchange programs for undergraduate and postgraduate, doctorate students

- joint scientific research work on the approved subjects
- joint preparation of PhD students in the fields preferred by each party on the basis of reciprocity
- collaboration in preparing and publishing scientific articles and monographs
- sharing views and appointing opponents for research work and postgraduate thesis
- creating facilities to defend Master's and PhD thesis prepared by their counterparts
- joint participation and organization of international academic workshops, symposiums and conferences
- organizing exchange of academic internships
- Academic support of Arabic language teaching in L.N.Gumilyov Eurasian National University
- arranging double diploma projects
- exchange of experience in the field of instruction methods and techniques
- sharing website links and other promoting procedures

**Article 5**

The Parties shall support professors and students to execute mutually beneficial joint scientific research projects.


**Article 6**

The Parties shall support publishing scientific work of the other Party's scholars and researchers in their periodicals, conference and symposium proceedings.

**Article 7**

The Memorandum is valid for a period of five years from the date of signing. The validity of the Memorandum may be automatically prolonged for the same term. Each Party has the right to unilaterally terminate this Memorandum by informing the other party in the written form 60 days prior to the date of its termination. The Memorandum is made on two authentic copies in Arabic, Kazakh, and English; each has an equal legal force. In case of disputes on explaining provisions of the Memorandum, the English version shall prevail.
